**WIRE TRANSFER STOCK** (to the account of Children's Ministries International, Inc. at CHARLES SCHWAB)  
Call your broker. Let him know that you would like to transfer stock to the account of Children's Ministries International, Inc. at CHARLES SCHWAB. Instruct the broker NOT to sell the securities. Also tell your broker the kind of stock and number of shares you would like to transfer.

### **IRA CHARITABLE ROLLOVER**

If you own an IRA and are over age 70½, you may transfer up to \$100,000 directly from your IRA to Children's Ministries International, Inc. because we are a qualified charity. You may not have taken your 2011 required IRA distribution and may reduce your income taxes with an IRA Charitable Rollover. Even if you have taken your required IRA distribution, you still may find the IRA Charitable Rollover a very convenient way to make a year-end gift.

- An easy way to start your IRA Charitable Rollover is to contact your IRA Custodian. This is usually a financial services company that manages your IRA. Please check their website for the correct phone number or e-mail address.
- Instruct your IRA Custodian to transfer a portion of your required minimum distribution directly to Children's Ministries International, Inc.
